



RULES AND REGULATIONS OF THE "SELVA DEL BUFFARDELLO" ADVENTURE PARK

You are reminded that access is to be given to various acrobatic courses, **which may be associated with a level of physical risk**. We recommend that you take note of the following rules and recommendations.

• Conditions to accessing the various acrobatic courses:

1. **A good overall physical ability is needed.** Any cardiac, medical or health related conditions, may inhibit the individuals ability to successfully complete the activity. No persons under the influence of any drugs or alcohol may be permitted to participate. It is forbidden for any pregnant / expecting woman to access the courses.
2. The correct clothing is recommended; in particular shoes e.g. trainers or trekking, **no tops, no shorts**. Long hair is to be tied back.
3. It is compulsory that participants adhere to all instructions given by the Staff and Instructors.
4. Once having adhered to the above mentioned conditions a ticket will be issued.

• The cost of the ticket includes:

1. Usage of the various structures.
2. The hiring of the protective gear and accessories needed. Should the given time be exceeded, another ticket will have to be purchased.
3. A technical demonstration and briefing of the correct procedures and use of equipment will be provided, as well as, the instructors verification suggesting the individuals achieved level of competence.
4. Constant supervision, during the activity and any necessary intervention that may be needed.

• Compulsory procedures to be completed before commencing activity:

1. Participation in the activity briefing; involving, correct usage of all the equipment, protective gear and apparatus and a general understanding of procedures.
2. All participants will be required to perform a prerequisite practical trial. **The instructors reserve the right to suggest that participants who are unable to comply with the required competence or ability, may not progress further.**

Your safety and security is of paramount importance to us, please take note of the following criteria.

• Our park's acrobatic courses:

1. **YELLOW, ORANGE, VIOLET COURSES: A minimum height of 100 cm is required.** Children are to be CONSTANTLY supervised by the ground by a responsible person. *TICKET LIFETIME: 1 HOUR.*
2. **YELLOW, ORANGE, VIOLET, GREEN, BLUE COURSES: Only accessible to participants with a minimum height of 130 cm and maximum height of 140 cm, COMPULSORY ACCOMPANIED.** *TICKET LIFETIME: 1 HOUR AND 30 MINUTES.*
3. **GREEN, BLUE, BLUE PLUS, RED, BLACK, ZIPLINE AND FAST ZIPLINE COURSES: Only accessible to participants with a minimum height of 140 cm.** Children are to be CONSTANTLY supervised by the ground by a responsible person. *TICKET LIFETIME: 2 HOURS.*

• **During the courses:**

1. The participants need to pay the utmost attention to the instructions learnt. **In particular, the participants have to remain attached to the safety cable at all times. (The cable with the red marks).**
2. The organizers of any schools or groups are to take responsibility for their own participants.
3. A maximum of 3 participants are allowed on a platform at any given time.
4. A maximum of 1 participant is allowed at any given time on the ladders and any obstacles.
5. It is forbidden to swing, shake or bounce on any of the platforms and obstacles.
6. No objects are to be thrown from any of the platforms or obstacles.
7. It is forbidden to walk under any of the courses.
8. No smoking is allowed during the activity on the courses.

• **Please remember:**

1. **THE TICKET FOR THE COURSES IS NOT TRANSFERABLE AND/OR REFUNDABLE. In the event of bad weather, the adventure park may decide to close for safety reasons.** A refund will only be issued if participation has been less than 1 hour.
2. **The instructors reserve the right to suspend any participants who do not abide by the stipulated rules and regulations.**
3. **Photographic or video material may be used for any form of commercial use, no duty in return.**

DECLARATION ART. 46 E 47 D.P.R. 445/2000 ITALIAN LAW

Aware of the consequences of making false statements, falsehood of acts and use of false facts, punishable by law according to art. 76 D.P.R. n. 445/2000 and art. 496 of the Italian Penal Code, under my own responsibility, in order to enter the Park named “**Parco Avventura Selva del Buffardello**” and all its recreational areas, in San Romano in Garfagnana, Loc. DECLARES UNDER HIS/HER RESPONSIBILITY
